RECOMMENDATION

Adopt RESOLUTION NO. 2023-01 amending the regular meeting schedule for the North Orange County Cities JPA Board of Directors.

SUMMARY

Section 8 of the North Orange County Cities Joint Exercise of Powers Agreement states:

Meetings [of the Board]. The Board shall hold regular meetings at such place and time as the Board may establish in the Bylaws or by resolution, but shall not meet less frequently than one (1) time per year. The Board may hold special meetings as needed to carry out the purposes and objectives of the Authority. Meetings of the Board will be held in compliance with the Ralph M. Brown Act, Government Code Section 54940 et seq

DISCUSSION

In response to the requirements identified within section 8 of the JPA agreement, an amendment to the regular meeting schedule is being proposed. The proposal includes meeting annually on the second Tuesday of July at 3:00 p.m., with said meeting to be held in the City of Brea's Executive Conference Room located at 1 Civic Center Circle.

A RESOLUTION OF THE NORTH ORANGE COUNTY CITIES JOINT POWERS AUTHORITY AMENDING THE REGULAR SCHEDULE FOR MEETINGS OF THE BOARD TO BE HELD ONCE A YEAR

A. <u>RECITALS:</u>

WHEREAS, the North Orange County Cities Joint Powers Authority (Authority) has been established as a joint powers authority between the City of Brea and the City of Fullerton; and

WHEREAS, the Authority has been established as a vehicle for the development of creative, innovative, practical, and cost-effective programs to better provide municipal services; and

WHEREAS, the Authority seeks to enhance the municipal services provided to its citizens while increasing efficiency and cost savings; and

WHEREAS, this action adopts the date, hour, and place for regular meetings for the Board of the Authority.

B. RESOLUTION:

NOW, THEREFORE, the Authority resolves, finds, and determines, on the basis of the facts set forth in the agenda report presented to it and any testimony received at the meeting at which this matter was considered, as follows:

- 1. FINDS that this action is consistent with the purposes of the Authority.
